EVERY ONE OF OUR PROGRAMS IN YOUTH DEVELOPMENT OFFERS FINANCIAL ASSISTANCE TO THOSE WHO CAN'T AFFORD TO PLAY. WE NEVER DENY THE OPPORTUNITY FOR ANYONE TO PARTICIPATE.


